SHIPPED SEMEN STALLION SERVICE CONTRACT

This certifies _____, herein referred to as Mare Owner, has engaged one breeding to _____ for the _____ breeding season at \$ _____ which includes a non-refundable booking fee of \$ _____ for the following mare:

Cooled semen (subject to availability) \$550 first shipment which includes Chute Fee, Collection Fee, Extender, and FedEx overnight shipping

Frozen semen (can be ordered and received before mare is ready to be bred)

Lexlin Gypsy Ranch, agent for the above named Stallion, will herein be referred to as Breeder.

This Stallion Service Contract is entered into subject to the following:

1. Breeder agrees to ship semen to Mare Owner, a previously arranged agent or breeding facility. All arrangements to ship to a location other than the Mare Owner's address provided below must be made and finalized 10 days prior to the first shipment. This contract is governed by the laws of Blount County and the State of Tennessee.
2. Cooled semen will be shipped in a container provided by Lexlin Gypsy Ranch. If the equitainer is not returned within 5 business days, Mare Owner will be charged \$500. Up to four subsequent shipments will be allowed at \$550 each. If counter to counter is required, charges will be approximately \$300 depending on shipping rates by carrier.
3. The breeding season in force for this contract shall begin February 15th and close October 15th of the year covered by this contract.
4. It is agreed that should the above named Stallion die or become unfit for service, the Mare Owner may breed to another Stallion on the farm upon mutual agreement of Mare Owner and Stallion Owner. It is further agreed that if the above named Mare dies during the breeding season, the Mare Owner may substitute another Mare agreed upon by both parties.
5. A photostatic copy of Mare's registration papers (both sides) shall be sent to Breeder with this contract.
6. Live foal guarantee. Live foal means the foal shall stand and nurse. It is understood that should mare prove barren, abort her foal, or if the foal is stillborn, a return season will be guaranteed the following year only, providing notification is given. Proper notification shall be defined as follows: Written certification by licensed veterinarian within seven days that the mare has slipped or produce a non-viable foal. Mare Owner certifies that such abortion or death did not result from any act or omission of the owner subsequent to the mare's departure from Lexlin Gypsy Ranch. Booster pneumabort rhinopneumonitis vaccinations must be administered as indicated by the individual drug manufacturer as the mare progresses through her pregnancy. Failure to do so will void live foal guarantee.
7. It is understood that mares in residence at Lexlin Gypsy Ranch (ranch Mares) will be given priority for semen.
8. Should the above named Mare fail to settle after 5th shipment, the Mare Owner has the option of bringing the above named Mare or a substitute Mare, agreed upon by both parties, to the ranch to be bred. Should a Mare fail to conceive or not produce a viable foal and rebreeding the following year becomes necessary, a \$550 rebreed fee which includes Chute Fee, Collection Fee, Extender, and FedEx overnight shipping. No live foal guarantee on third year rebreeds.
9. Due to increased national security measures, Lexlin Gypsy Ranch cannot be held liable for semen once the shipment leaves the property of Lexlin Gypsy Ranch.
10. The rider entitled "Lexlin Gypsy Ranch Shipped Semen Guidelines" is attached heretofore and made a part thereof.
11. A breeder's certificate will be issued to Mare Owner after all ranch, veterinary and farrier expenses have been paid in full and upon notification of the birth of the foal.
12. This contract is not valid unless completed in full. When Mare Owner signs and returns contract and booking fee to Breeder, it will become a binding contract on both parties, subject to the above terms and conditions. This contract is not transferable or assignable.
13. All breeding and shipping fees, where applicable, must be paid in full prior to shipment of semen.

14. There is a \$75 fee for picking up semen at the ranch.
